### **Qualifications:**

All Trade pass requests will be qualified before issuing credentials. You will be required to provide your business card at registration for the Tasting on November 20, 2010. A maximum of 2 attendees per company allowed at Trade rate. Submission of your trade reservation does not guarantee admission.

**No registration accepted after November 5, 2010.** Trade must register on-site after the cut-off date. On-site registration fee is \$75 per person. There is limited space for Trade Attendees. **No one under 21 permitted, including infants.**
